## **Tillfällig lagring Testfall 2**

*Deklaration för tillfällig lagring (TSDP) lämnad innan ankomst där direkt ombudet är insändande part.*

**Meddelande:** TSDP, *deklaration för tillfällig lagring* lämnad innan ankomst.

**Förutsättning:** En *deklaration för tillfällig lagring* lämnad innan ankomst (TSDP), skickas elektroniskt till Tullverket. Ärendet består av en *Deklarationsnivå*, en *Master Consignment-nivå*, en *House Consignment-nivå* och en *House Consignment Item-nivå*.

**Resultat:** TSDP sänds in av *deklaranten* till Tullverket. Tullverket skickare ett svarsmeddelande, TLKVT, med statuskod TEM (Teknisk mottagen), till *deklaranten* som talar om att deklARATIONEN är tekniskt mottagen. Tullverket validerar deklARATIONENS innehåll och skickar ett svarsmeddelande KVT med statuskod ING (Ingiven) till *deklaranten*. Svarsmeddelandet använder deklARATIONENS LRN (Local Reference Number) som referens och innehåller tilldelat MRN (Master Reference Number).

1. *Deklaranten* sänder in TSDP.
2. *Deklaranten* tar emot svarsmeddelande TLKVT med statuskod TEM.
3. *Deklaranten* tar emot svarsmeddelande KVT med statuskod ING som innehåller tilldelat MRN.
